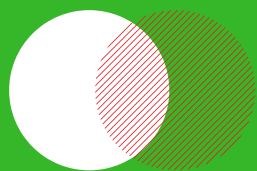
The **ZIMBABWE INVESTMENT FORUM** is brought to you by **Regions of Africa** and the **Australia Zimbabwe Business Council**.

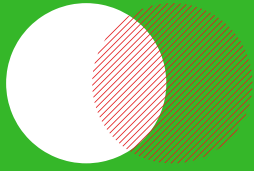

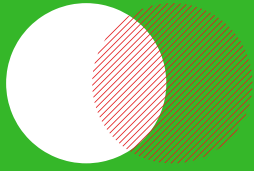


Isaac Kwesu

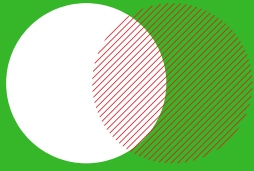

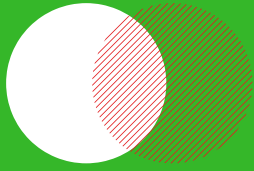

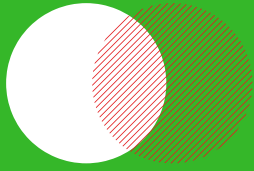
Sam is the Managing Director of Prospect Resources.

The Ministry's efforts are underpinned by the Zimbabwe economic recovery focus which is very clear on the role of mining sector in reviving the Zimbabwean economy.

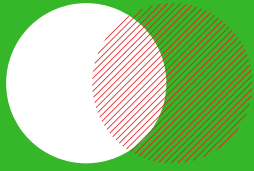
Chamber of Mines Zimbabwe

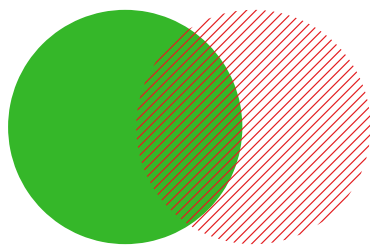
